

Summertime Camp Regulations and Policies - 2021

Welcome to Summer Camp!

IMPORTANT INFORMATION:

The Good Shepherd School follows all CDC travel and gathering guidelines. These guidelines will also be followed by our GSS Summer Camp. Currently, we require that children be tested for Covid-19 3-5 days after travel and 5 days after travel involving public transportation such as commercial flight. The child must not attend camp until the recommended 7 days have passed and a negative test result is provided using documentation provided by the testing site. Please plan accordingly when registering your child for camp with respect to your vacation/travel plans. There will not be any refunds due to Covid-19 testing which is currently required after travel.

*All campers will be expected to wear a face mask at all times while on campus except while eating or drinking. All adults bringing to and picking up from camp must wear a face mask at all times while on campus as well.

The CDC guidelines may change prior to the start of camp or once the camp season is in session. We will update families of changes as they are communicated to us through Maryland State Department of Education and/or the Baltimore County Health Department.

In addition:

- We may be using sprinklers and water tables during camp.
- Please apply waterproof sunscreen to your child before camp in the morning, even if the day appears cloudy. Upon written request, we will apply additional sunscreen to your child. Only sunscreen provided by the child's parent/guardian will be used.
- We are a Nut-Free Environment. Safety is our primary concern. Please do not pack nut products of any kind in your child's lunch.
- Freeze pops will be enjoyed as a snack on camp days.
- Children must be potty-trained.
- Arrival/Dismissal: We will be using a staggered arrival schedule from 8:50-9:10 a.m. Dismissal times will be scheduled between 12:20 and 12:40 p.m. Parents will be notified of their child's arrival and dismissal times by the week prior to camp. Children will not be released to anyone (except parent/guardian) without written permission. The Brightwheel app will be used to check the children in and out of camp. Currently, daily health screens and temperature checks are required by MSDE which will be recorded in the Brightwheel App.
- A Parent/Caregiver must provide a thermometer and perform a temperature check upon arrival at morning check-in.

EVERY DAY please provide your child with:

- A lunch (All food must be nut-free.) Please label sandwiches that look like they may contain peanut butter as "peanut free." Lunches will be stored in refrigerators or coolers.
- A drink refillable water bottle
- Two extra masks
- Water shoes
- A bathing suit: Please make sure your child wears a bathing suit under his/her shorts each day. For girls, a two-piece bathing suit is recommended for ease in using the bathroom.
- A towel: Please label all towels with child's name.
